### **Superintendent Report**

Supt. Sullivan reported he will working with YBGR on the budget process. Current discussions are on reimbursing the Yellowstone Academy educational dollars based on Medicaid reimbursement rate of \$69 per day per student. This would amount to approximately \$1,000,000 per year. The foundation is also interested in providing reimbursements for the entire Vo-Ed program. The board discussed the possibility of meeting technology and curricular needs with this funding.

The board discussed yearly training with employees as well as the development of an evaluation tool for teachers.
