NEW BUSINESSBills - bills were submitted for approval. There was discussion on

CSCT contracted services, the MSU-B class fee for the Supt. endorsement, and future therapy bills being minimized if they can be offset by some CSCT services. James Holliday moved,

Supt. Sullivan reported on the following:

- 1. Supt. Sullivan updated the board on the negotiation process. The team has met with the parprofessionals last Thursday and will again meet this Thursday. Wednesday the teachers will meet for the first time;
- 2. The board will hold a special board meeting on Thursday, May 30th at 3:45 p.m. to discuss personnel hiring for the 2013-14 school year;
- 3. A letter was included from the Department of Commerce accepting the recommendations from the 2011-12 audit replies;
