A motion was made by Michael Chandler to approve long-term sub Kerri Ranta. Michael Chandler moved, seconded by Mitch Burns to rehire Supt Keith Tresch to a new 3 year contract. Both motions passed unanimously.

## **Approve Resignations**

A motion was made by Michael Chandler, seconded by Mitch Burns to approve the resignations of Raelynn Melber as a teacher. Motion passed unanimously.

#### **Approve DS Tuition Agreements**

## **Superintendent Report**

Supt. Keith Tresch reported on the following:

- 1) Supt. Tresch stated he is working on summer school hours. Lunch time will be from 11:30 12:15 p.m.;
- 2) Supt. Tresch informed the board that they will be hiring a recent graduate to work in the pheasant area. He will be working a couple of days a week for \$10-\$12 per hour;
- 3) Supt. Tresch stated they are looking for additional space and a possible rental of a portable classroom. The intent is for safety concerns and to keep smaller classrooms;
- 4) They are looking at creating 3 spaces with Cass Cole's office as well;
- 5) Certified negotiations just about complete offered 3.5% each year for 2 years and \$600 to go toward health insurance;
- 6) They have one more graduation to go today.
